## **MEETING MINUTES**

## February 6, 2022, 6:30pm

3. Benita Asher (Founding Member & Secretary) presented a summary of ATC's past, present and future.

Since its founding in 2002, ATC has provided numerous tennis programs and tournaments for youth and adults, as well as funding for public tennis facility improvements. ATC's current board is looking to transition the organization to capable new hands with the time and energy to expand programming and return ATC to some of its former glory. Ideas for future offerings include adult beginner/novice drop-in with guest instructors, return to annual tournaments, summer and off-season programming, and building our relationship with the local pickleball group.

Benita described ATC's all-volunteer board, officer positions, and rough time commitment.

- 4. Sheilah Asher (Treasurer) presented ATC's 2021 financial summary including JTT profit (one season), dues and ball machine dues, and bank account balance.
- 5. Lyndsey Sammons (JTT League Director) presented a JTT summary Super successful Fall 2021 season had 65 kids/16 coaches. Goals for future include JTT pathway to show how players move through the different levels of play, improving marketing (with parent help), explore team sponsorship idea.
